- Full description of the cargo
- Value (and currency)
- Customs Tariff heading (B.T.T.N)
- A declaration that "these goods are of..... origin for exhibition at LABELEXPO EUROPE 2022 – Media Partners."

Shipments must be despatched on a "DDP" basis with all import formalities, duties and taxes paid by the courier company and charged to the shipper's courier account. We will receive your shipments from the Courier Company, sign for the receipt and deliver to your stand based on the schedule of charges hereunder.

Please note: We cannot accept shipments where any charges are payable by the consignee.

Should we find ourselves in a position where we are obliged to complete Import Customs formalities on a courier shipment, the full cost of clearance, document, bond fees, duties, taxes and agency fees will be payable prior to delivery to the exhibition. Our Customs tariff will apply.
